MINUTES

Snow/Ice Event

The Council discussed the forecasted snow/ice event and the related safety concerns.

COUNCILWOMAN SCOTT MADE A MOTION TO AUTHORIZE SUSAN PARKER, TOWN ADMINISTRATOR TO DECLARE A STATE OF EMERGENCY IF DEEMED NECESSARY BY THE WEATHER CONDITIONS. COUNCILMAN SHERRILL SECONDED THE MOTION. MAYOR WATTS CALLED FOR A VOTE AND THE MOTION CARRIED BY UNANIMOUS VOTE.

COUNCILMAN SHERRILL MADE A MOTION TO AUTHORIZE SUSAN PARKER TO SUPERSEDE THE STATE OF EMERGENCY PROCLAMATION IF DEEMED NECESSARY BY WEATHER CONDITIONS. MAYOR PRO-TEM DEVITA SECONDED THE MOTION. MAYOR WATTS CALLED FOR A VOTE AND THE MOTION CARRIED BY UNANIMOUS VOTE.

COUNCILWOMAN SCOTT MADE A MOTION TO NAME SUSAN PARKER, TOWN ADMINISTRATOR AS THE DESIGNATION OF AUTHORITY DURING THE FORECASTED SNOW/ICE EVENT. COUNCILMAN SHERRILL SECONDED THE MOTION. MAYOR WATTS CALLED FOR A VOTE AND THE MOTION CARRIED BY UNANIMOUS VOTE.

MAYOR PRO-TEM DEVITA MADE A MOTION TO AUTHORIZE SUSAN PARKER, TOWN ADMINISTRATOR, TO LIFT THE STATE OF EMERGENCY WHEN DEEMED APPROPRIATE. COUNCILMAN SHERRILL SECONDED THE MOTION. MAYOR WATTS CALLED FOR A VOTE AND THE MOTION CARRIED BY UNANIMOUS VOTE.

COUNCILWOMAN SCOTT MADE A MOTION TO ADJOURN THE JANUARY 27, 2014 EMERGENCY MEETING. COUNCILMAN SHERRILL SECONDED THE MOTION. MAYOR WATTS CALLED FOR A VOTE AND THE MOTION CARRIED BY UNANIMOUS VOTE.
