



**AN ORDINANCE TO AMEND
CHAPTER 95
BEACH STRAND, WATERWAY, CHANNEL AND CANAL REGULATIONS
REGULATING THE ASSOCIATED PENALTIES**

BE IT ORDAINED by the Town Council of Sunset Beach that the following Section of Chapter 95 of the Code of Ordinances is hereby amended to read as follows:

§ 95.99 - FINES AND PENALTIES.

~~Notwithstanding section 10.99, violation of any section of Chapter 95 shall subject the offender to a civil penalty as follows:~~

Violation of this section shall not constitute an infraction or misdemeanor under NCGS 14-4, but shall subject the violator to a civil penalty to be recovered by the Town in a civil action in the nature of debt if said civil penalty is not paid within 72 hours after being cited for the violation. Unless otherwise specified in the Code of Ordinances, the civil penalty for each separate or distinct offense shall be as follows:
