



Superseding Proclamation for the Town of Sunset Beach

WHEREAS, a State of Emergency has heretofore been proclaimed pursuant to the laws of North Carolina and the ordinances of the Town of Sunset Beach; and

WHEREAS, the Mayor deems it appropriate to amend the Proclamation establishing the existence of a State of Emergency as follows:

NOW, THEREFORE, pursuant to Chapters 160A, 166A and 14 of North Carolina General Statutes and further, under authority of the ordinances of the Town of Sunset Beach, the undersigned does hereby amend the following:

1. Proclamation dated the 23rd day of March, 2020, at 3:13 PM
2. Proclamation dated the 30th day of March, 2020, at 3:00 PM
3. Proclamation dated the 31st day of March, 2020 at 2:00 PM,
4. Proclamation dated the 6th day of April 2020 at 10:30 AM,
5. Proclamation dated the 6th day of April 2020 at 1:30 PM,
6. Proclamation dated the 4th day of May 2020 at 9:30 PM
7. Proclamation dated the 19th day of May 2020 at 10:00 AM
8. Proclamation dated the 1st day of June 2020 at 10:00 PM
9. Proclamation dated the 16th day of June 2020 at 10:30 AM
10. Proclamation dated the 6th day of July 2020 at 9:00 PM,
11. Proclamation dated the 4th day of August 2020 at 4:30 PM, and the
12. Proclamation dated the 6th day of August 2020 at 8:45 PM

By amending the Proclamation dated August 6, 2020 at 8:45 PM to read as follows:

1. Special events in the Town Park and within the Town limits are limited to a maximum of 25 people for an inside event and 50 people for an outside event. During any event, face masks are required and social distancing must be maintained. If the event is a concert, no food vendors will be allowed.

2. The Town Council will no longer accept public comments via email since a quorum of the Council is attending Meetings in person and the public is allowed to make comments from the Conference Room.
3. The public, business owners and employees are encouraged to wear a cloth mask or face covering when in public areas.
4. Rental Companies and private renters are encouraged to follow CDC guidelines when cleaning units.
5. Social Distancing requirements remain in effective until further notice.

Except as hereinabove amended and superseded, the Proclamations creating and amending the State of Emergency in the Town of Sunset Beach, dated the 23rd day of March, 2020 at 3:13 PM, dated the 30th day of March, 2020, at 3:00 PM, dated the 31st day of March 2020 at 2:00 PM, dated the 6th day of April 2020, at 10:30 AM, dated the 6th day of April 2020, at 1:30 PM, dated the 8th day of April 2020 at 4:00 PM, dated the 4th day of May 2020 at 9:30 PM, dated May 19, 2020 at 10:00 AM, dated the 1st day of June 2020 at 10:00 PM, dated the 16th day of June 2020 at 10:30 AM, dated the 6th day of July 2020 at 9:00 PM, dated the 4th day of August 2020 at 4:30 PM and dated the 6th day of August 2020, at 8:45 PM shall remain in full force and effect.

This Proclamation signed on the 8th day of September 2020, at 8:45 PM shall be in full force and effect immediately and shall remain in full force and effect until the State of Emergency is rescinded by Mayor Phillips.
