Dave Stuart, of whom submitted the Mylar for a town signature and; who is also the representative for Carolina Dreams developer/property owner, stated that the roads and ponds belong to those HOA's as per the Master Declaration for the Mixed Use District. The ponds and roads were never transferred to the Master Association.

The Planning Board completed their review, no vote was needed. Per the UDO, only a review of a subdivision is required by the Planning Board.

Hiram asked Dave Stuart to add a note on the Mylar that states that this is not a subdivision of all the tracts, it is a dedication of the roads and ponds.
