



Superseding Proclamation for the Town of Sunset Beach

WHEREAS, a State of Emergency has heretofore been proclaimed pursuant to the laws of North Carolina and the ordinances of the Town of Sunset Beach; and

WHEREAS, the Mayor deems it appropriate to amend the Proclamation establishing the existence of a State of Emergency as follows:

NOW, THEREFORE, pursuant to Chapters 160A, 166A and 14 of North Carolina General Statutes and further, under authority of the ordinances of the Town of Sunset Beach, the undersigned does hereby amend the following:

- Proclamation dated the 23rd day of March, 2020, at 3:13 PM
- Proclamation dated the 30th day of March, 2020, at 3:00 PM
- Proclamation dated the 31st day of March, 2020 at 2:00 PM,
- Proclamation dated the 6th day of April 2020 at 10:30 AM,
- Proclamation dated the 6th day of April 2020 at 1:30 PM,
- Proclamation dated the 4th day of May 2020 at 9:30 PM, and the
- Proclamation dated the 19th day of May 2020 at 10:00 AM

By amending the Proclamation dated May 19, 2020 at 10:00 AM to read as follows:

1. All scheduled special events in the Town Park and within the Town limits are canceled through June 26, 2020.
2. All Town owned restroom facilities are closed until further notice. Porta-Johns are located at the Gazebo and the Town Park for use at your own risk. Patrons are encouraged to bring their own toiletries.
3. All beach access walkways are one-way only with directional signs posted at each end. The ADA Walkways at the Gazebo, 1st Street, 3rd Street and 40th Street will be one direction for those without disabilities and multi-directional for those with disabilities.

4. The public, business owners and employees are encouraged to wear a cloth mask or face covering when in public areas.
5. Rental Companies and private renters are encouraged to follow CDC guidelines when cleaning units.
6. Social Distancing requirements remain in effective until further notice.

Except as hereinabove amended and superseded, the Proclamations creating and amending the State of Emergency in the Town of Sunset Beach, dated the 23rd day of March, 2020 at 3:13 PM, dated the 30th day of March, 2020, at 3:00 PM, dated the 31st day of March 2020 at 2:00 PM, dated the 6th day of April 2020, at 10:30 AM, dated the 6th day of April 2020, at 1:30 PM, dated the 8th day of April 2020 at 4:00 PM, dated the 4th day of May 2020 at 9:30 PM and dated May 19, 2020 at 10:00 AM shall remain in full force and effect.


